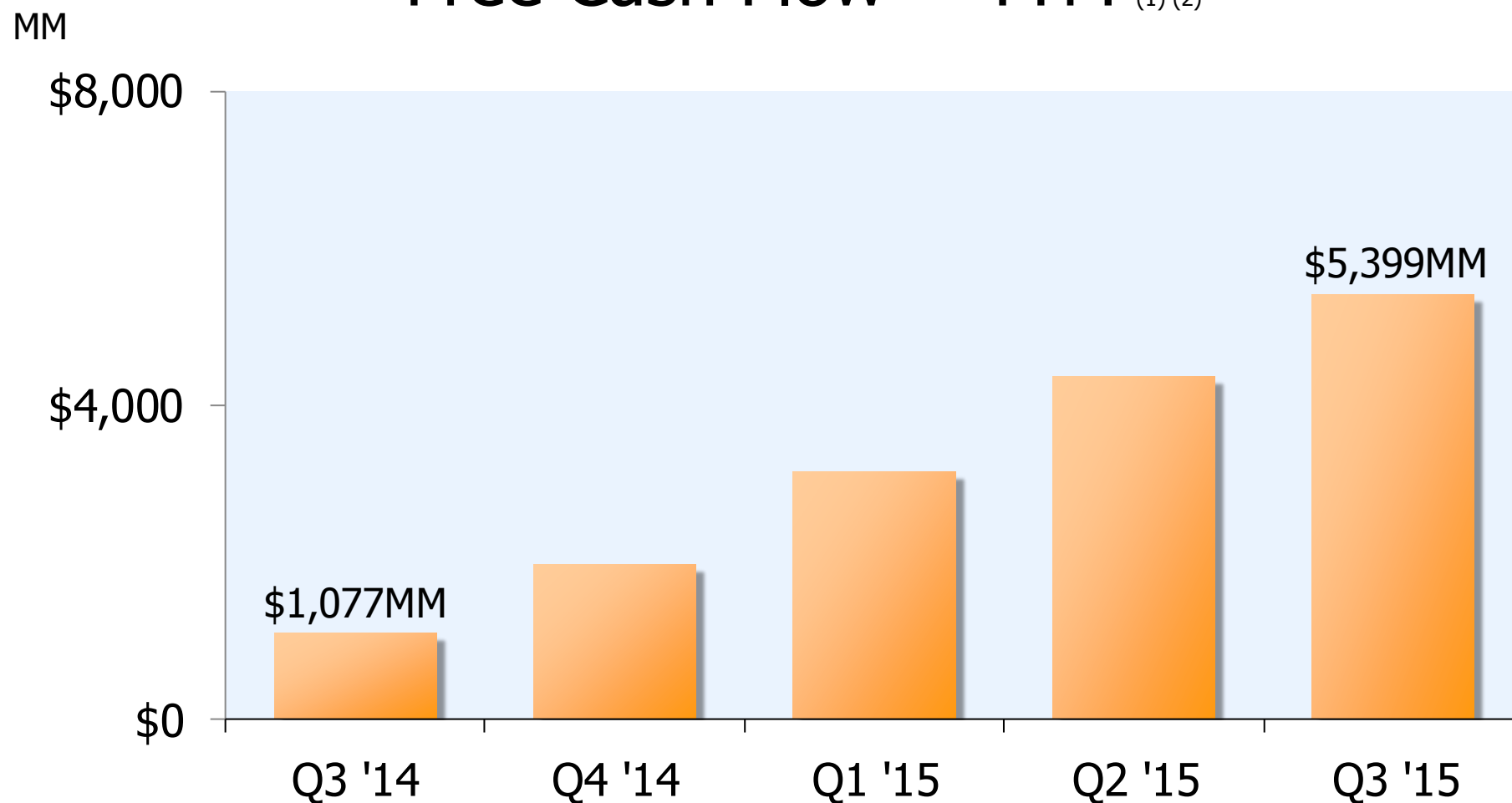

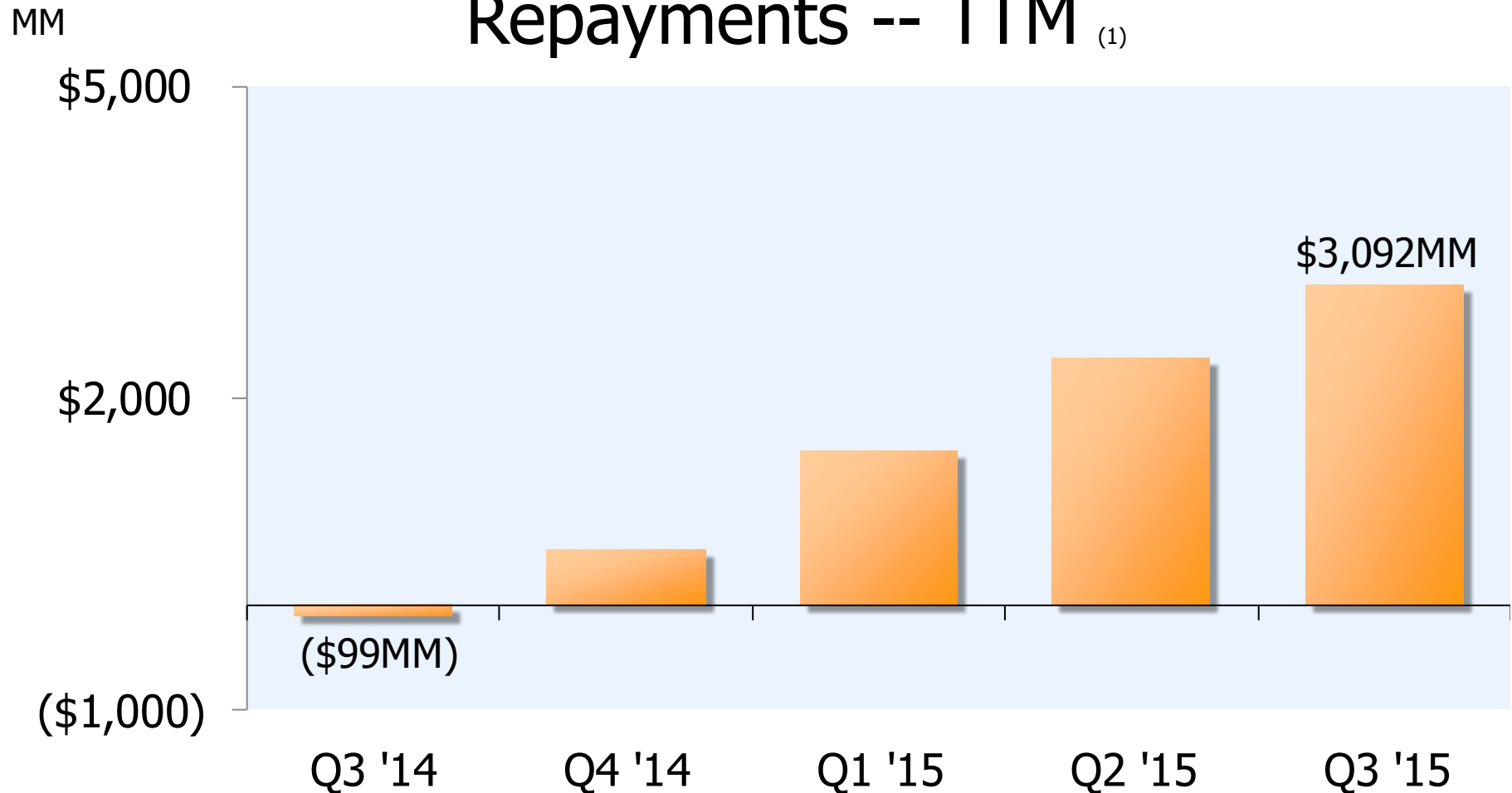
Free Cash Flow -- TTM ^{(1) (2)}

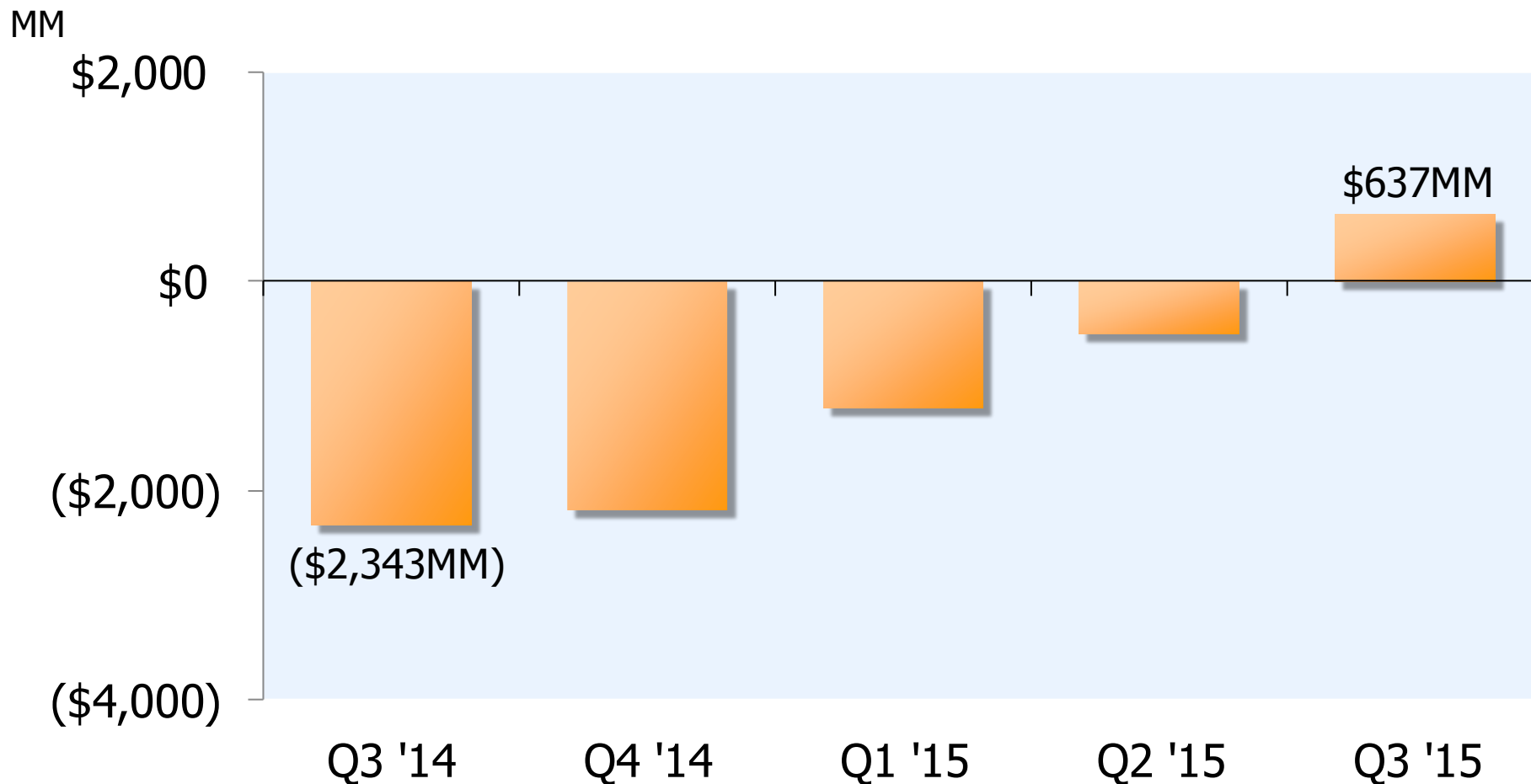
Free Cash Flow Less Lease Principal Repayments -- TTM ⁽¹⁾

Free Cash Flow Less Finance Lease Principal Repayments and Capital Acquired Under Capital Leases -- TTM ⁽¹⁾

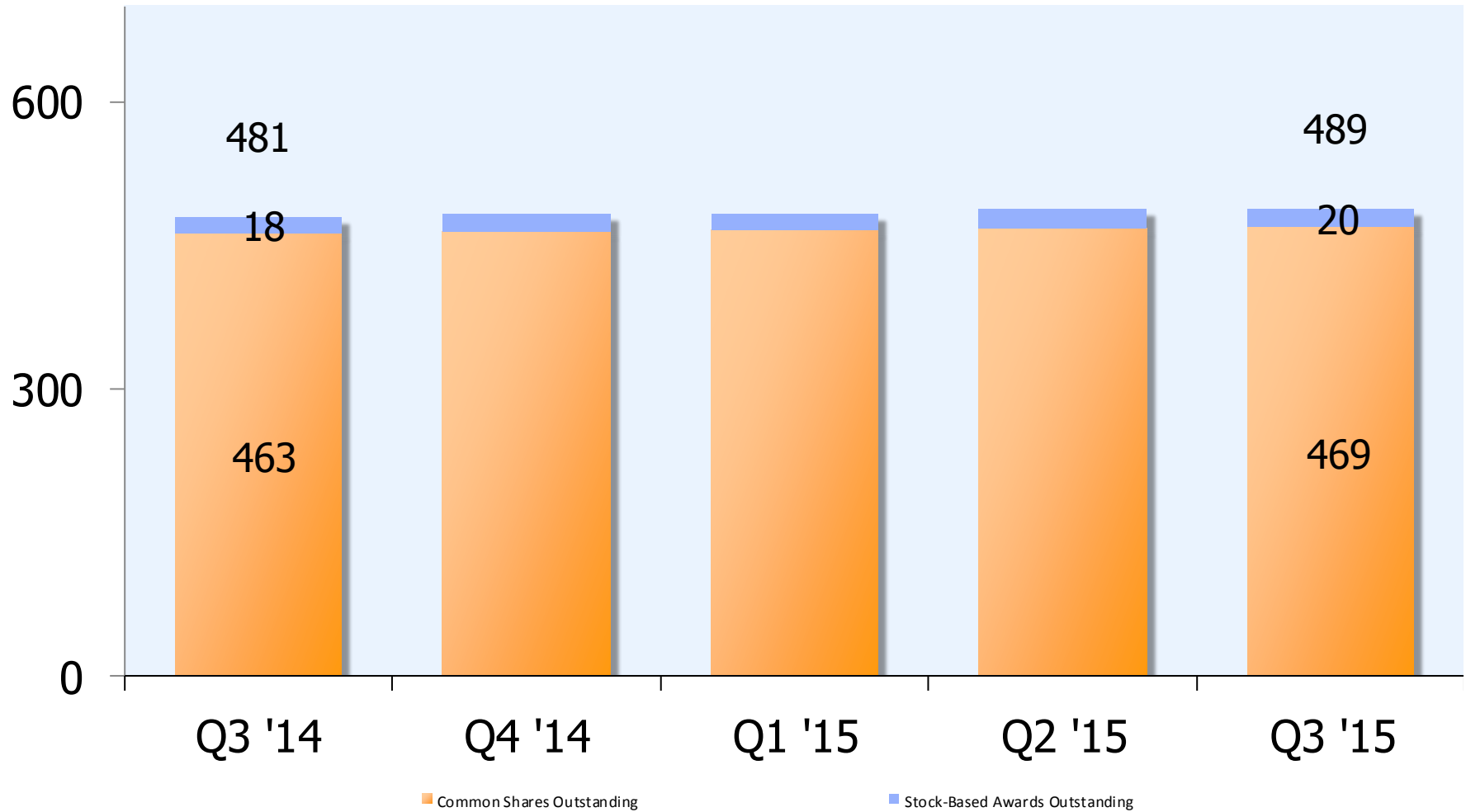

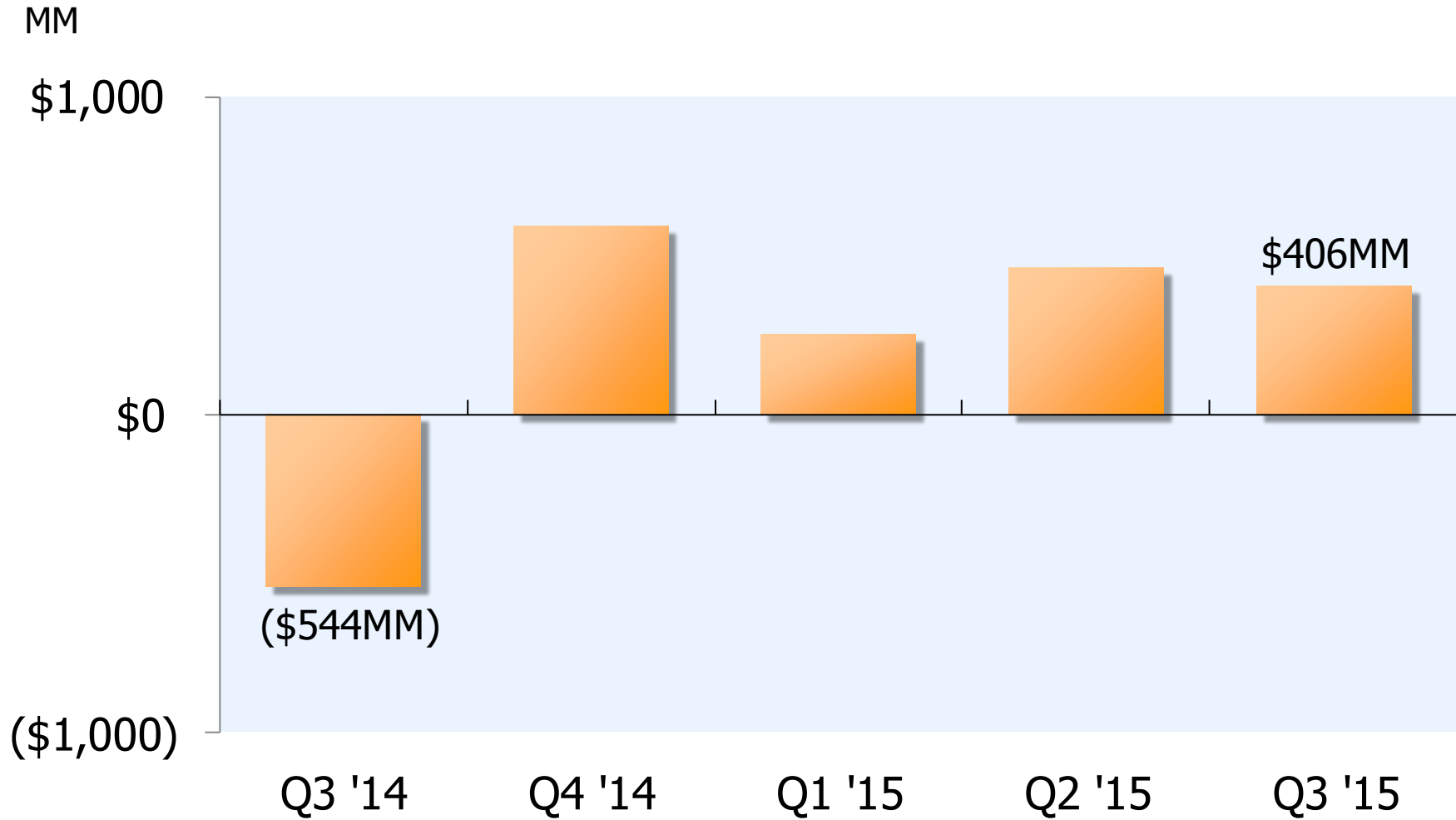

Net Sales – TTM

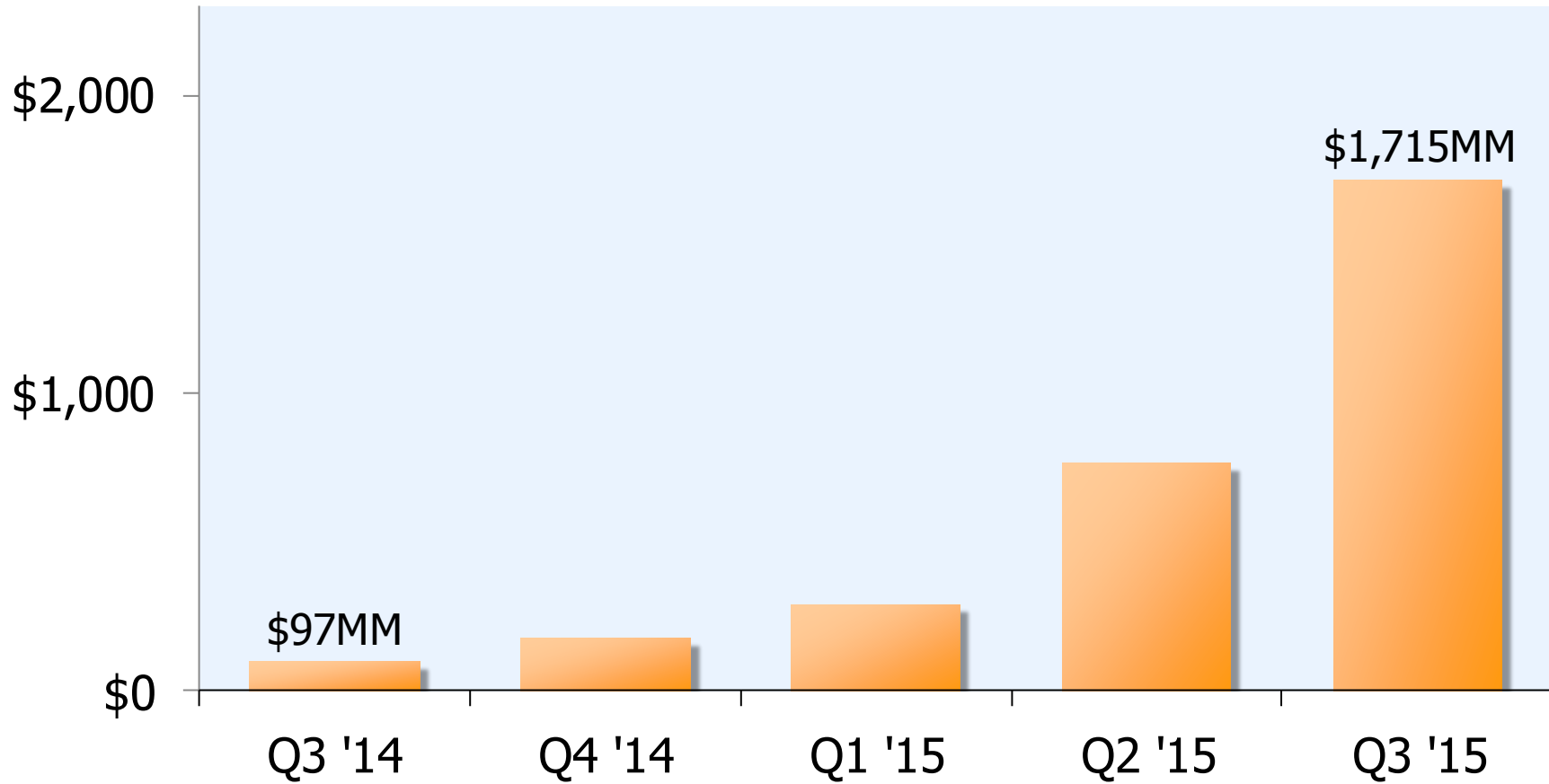


GAAP Operating Income (Loss)

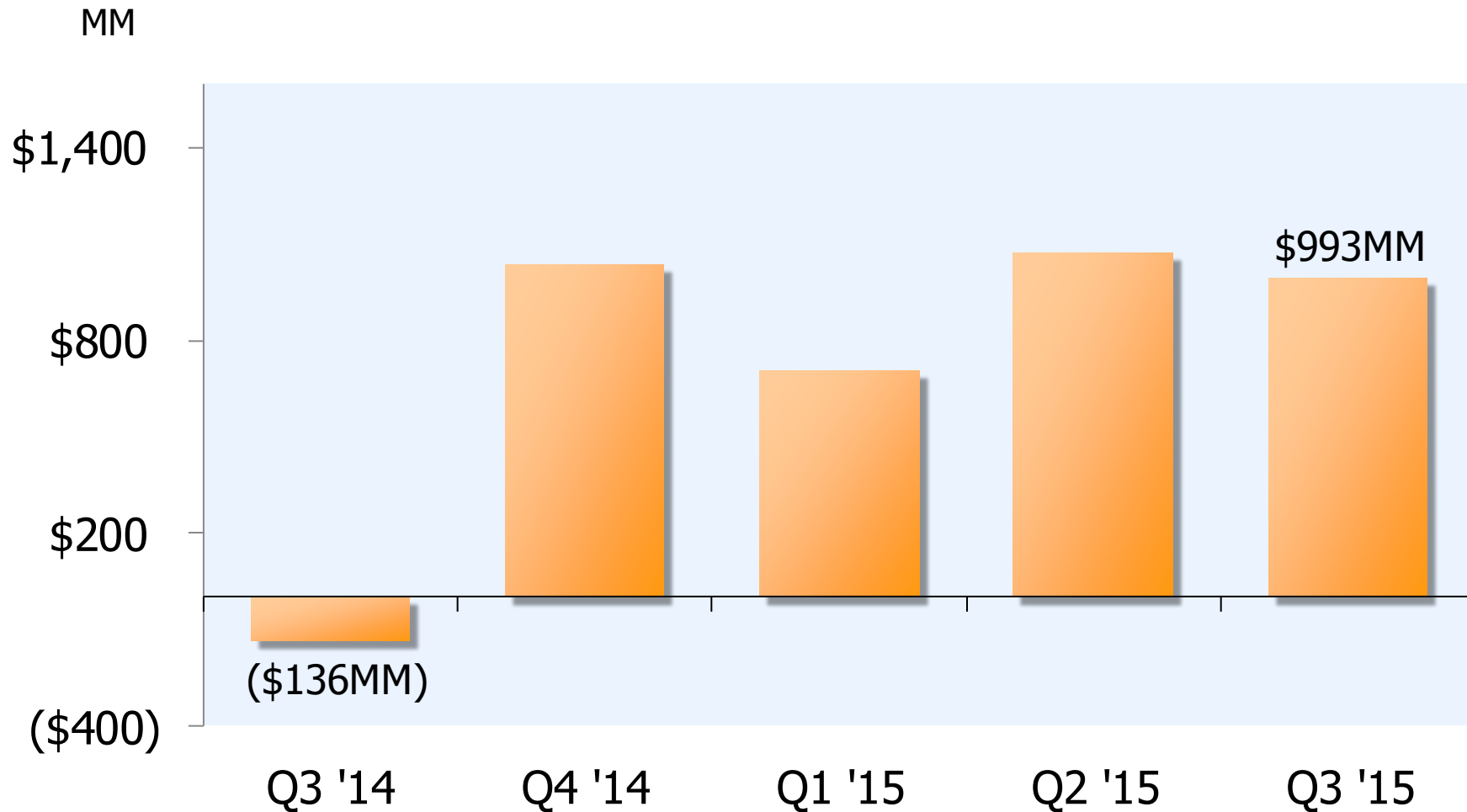

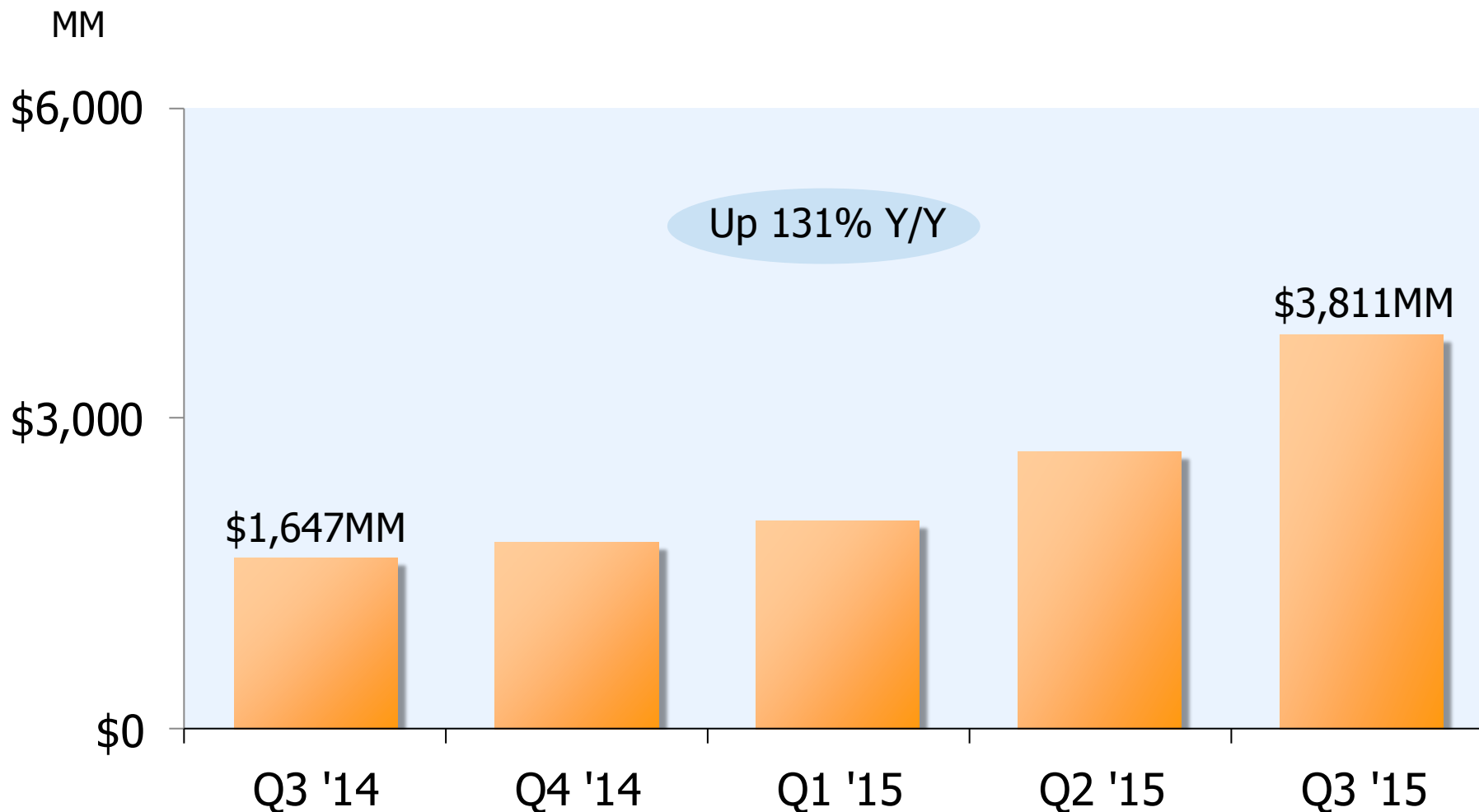


Consolidated Segment Operating Income (Loss) ⁽¹⁾



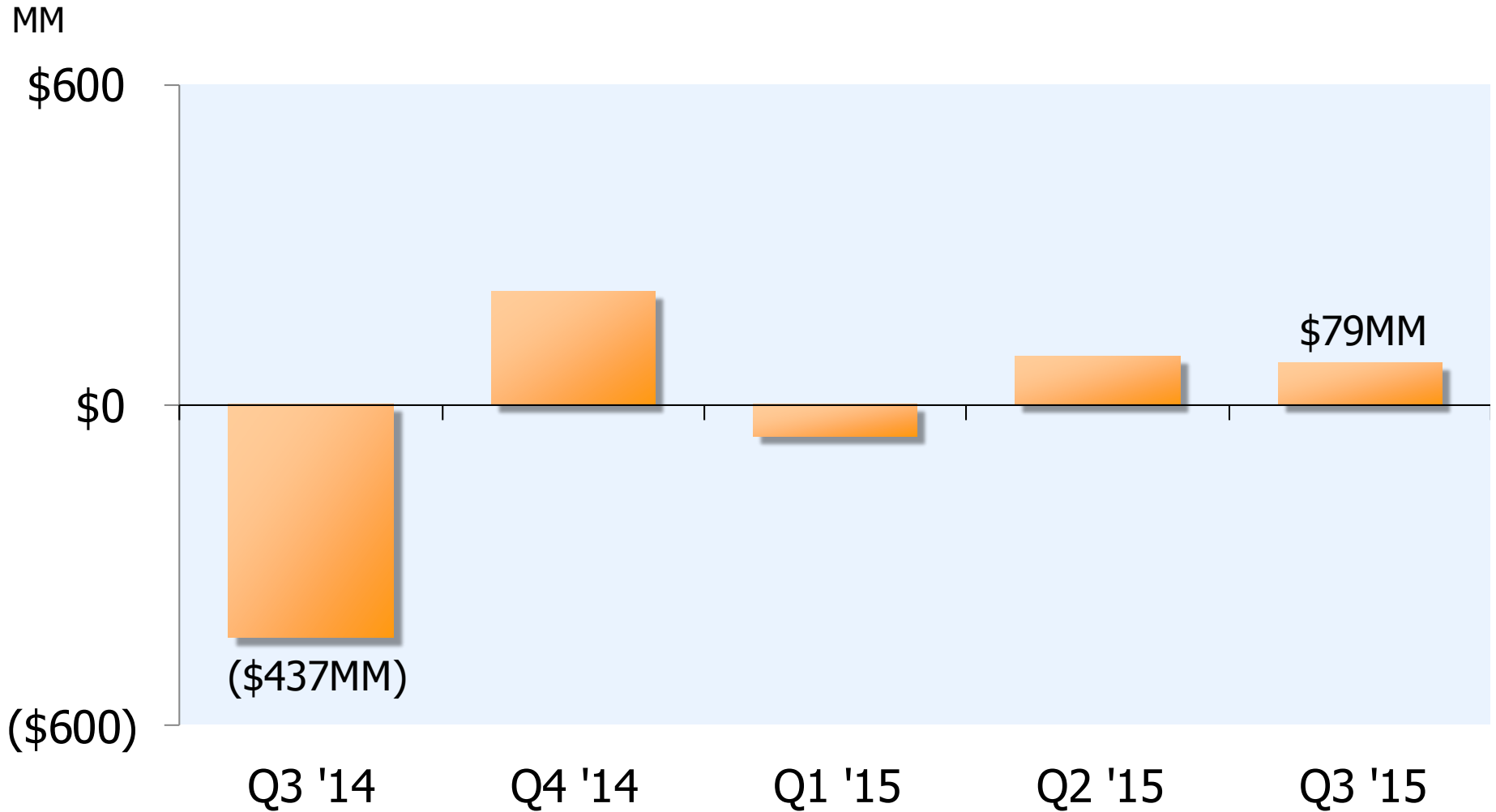

Consolidated Segment Operating Income -- TTM ⁽¹⁾

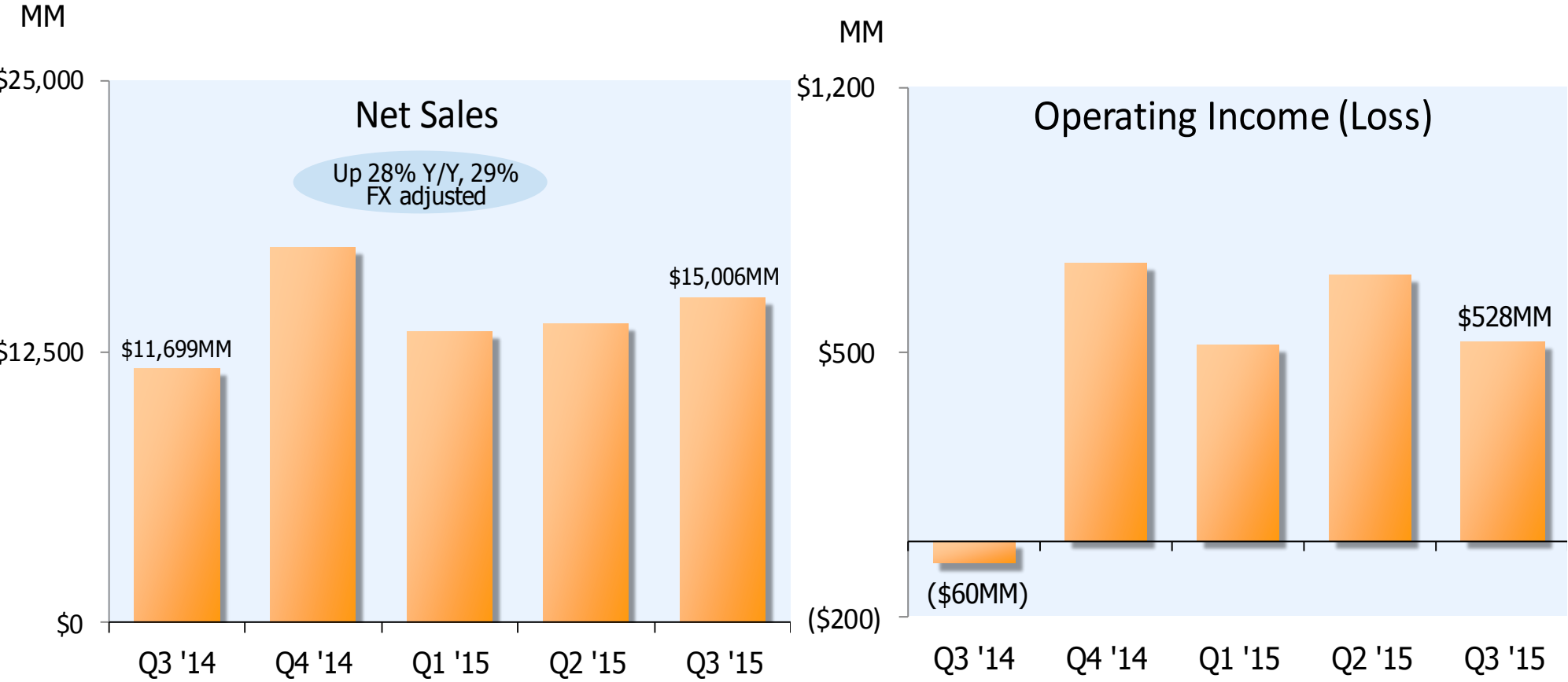

GAAP Net Income (Loss)

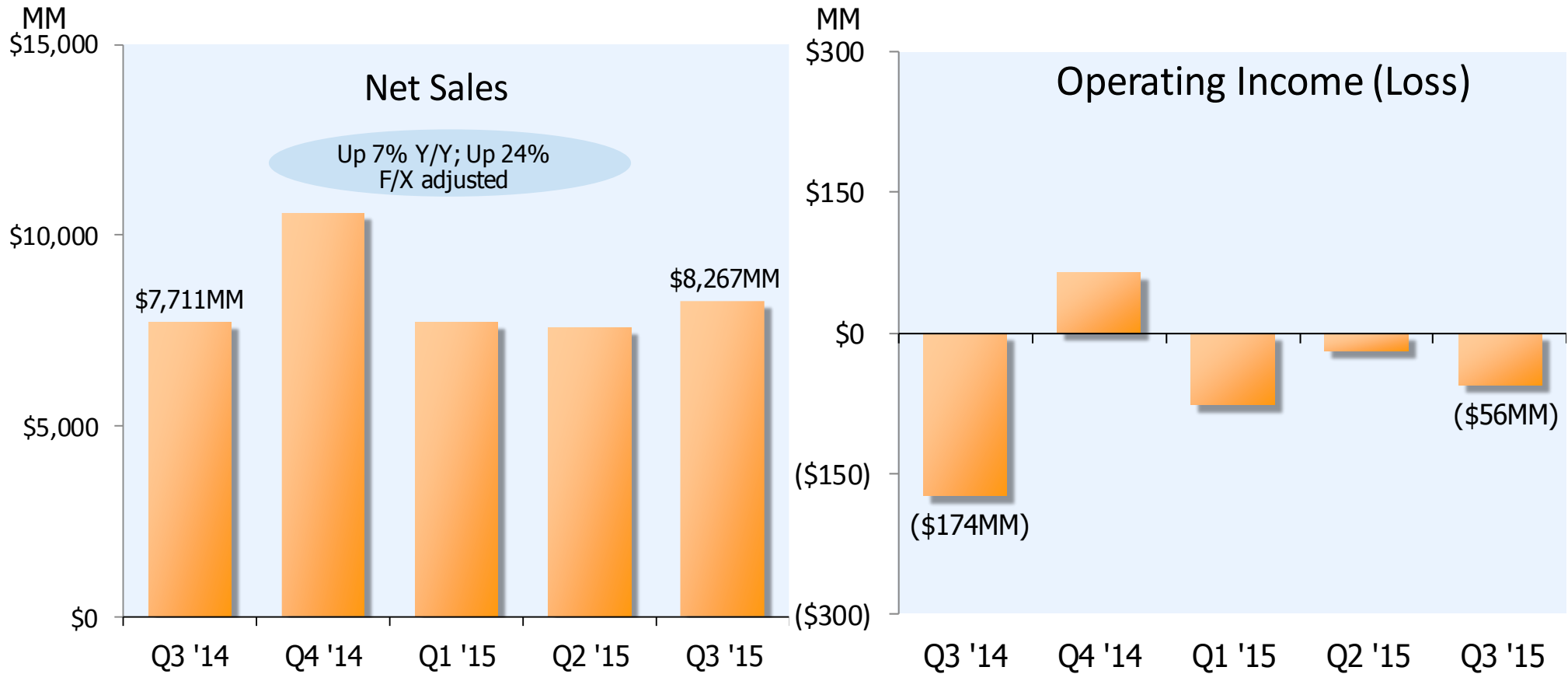


Segment Results – North America



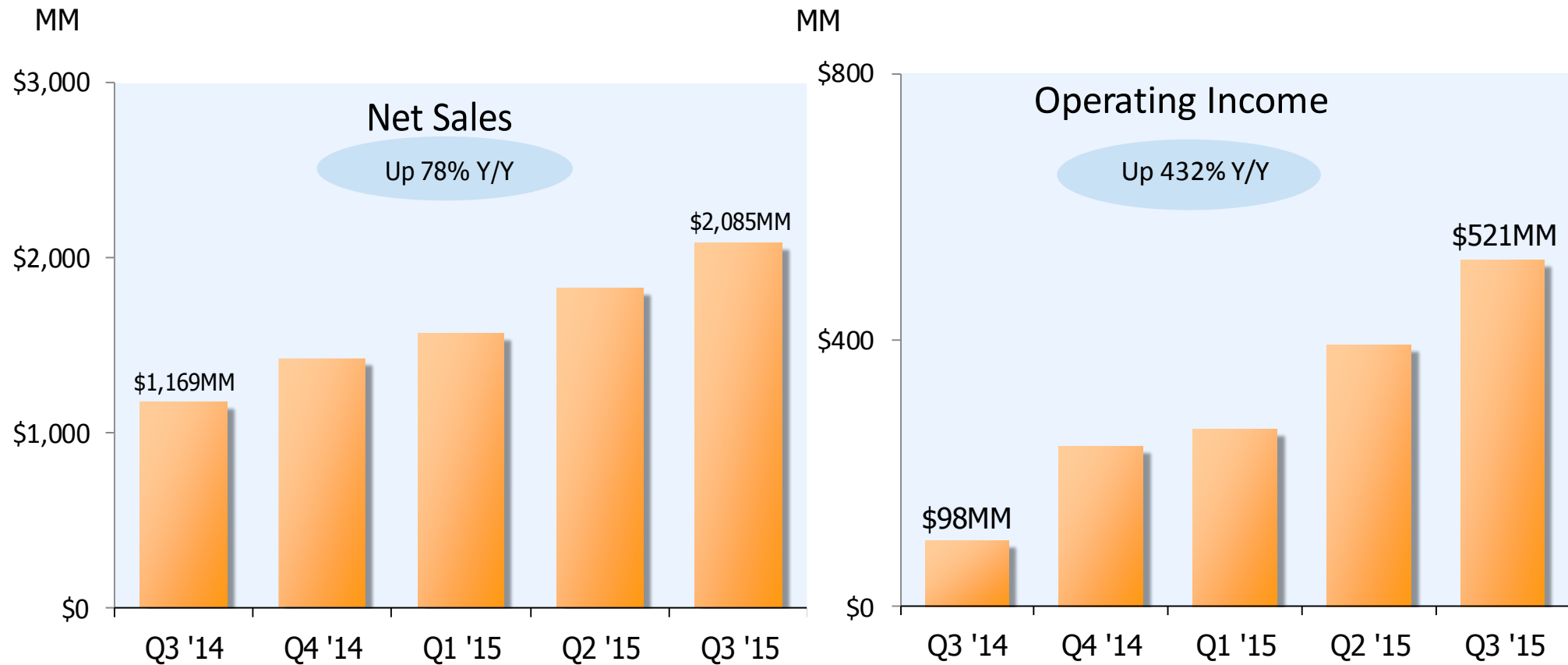

Segment Results – International



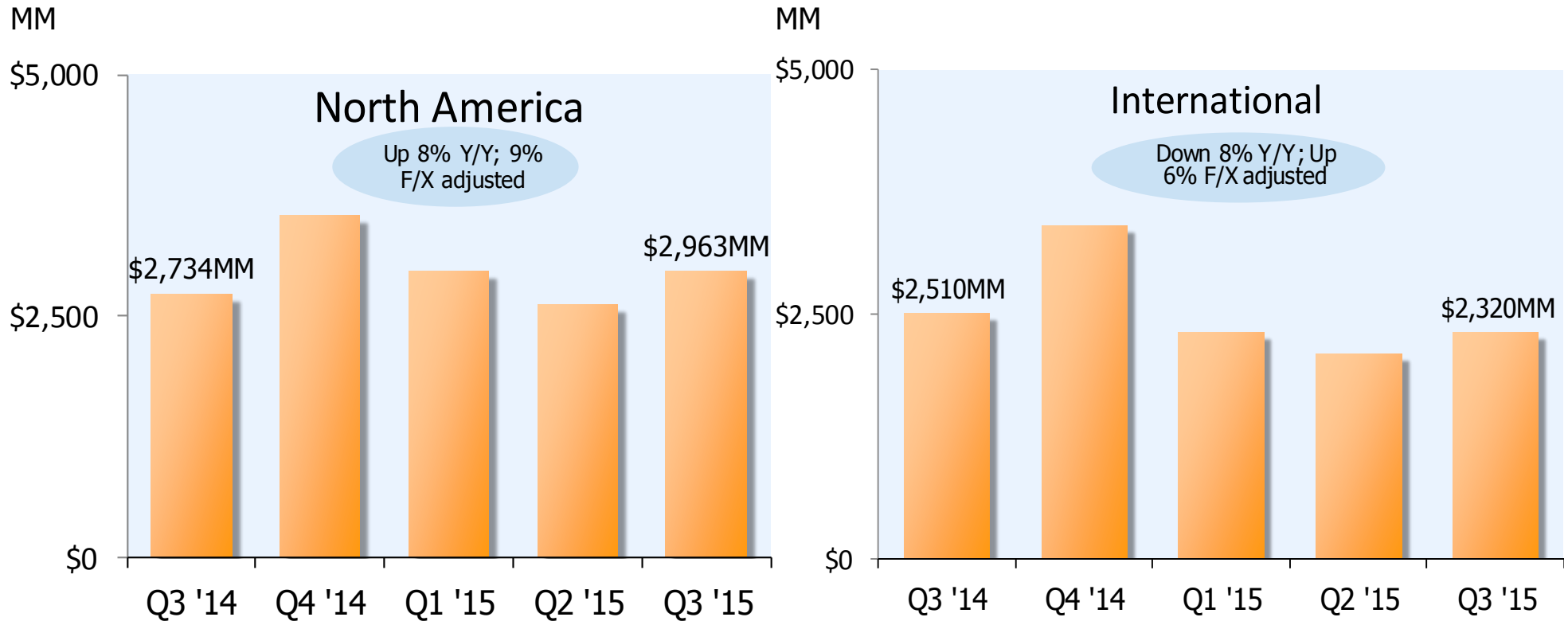

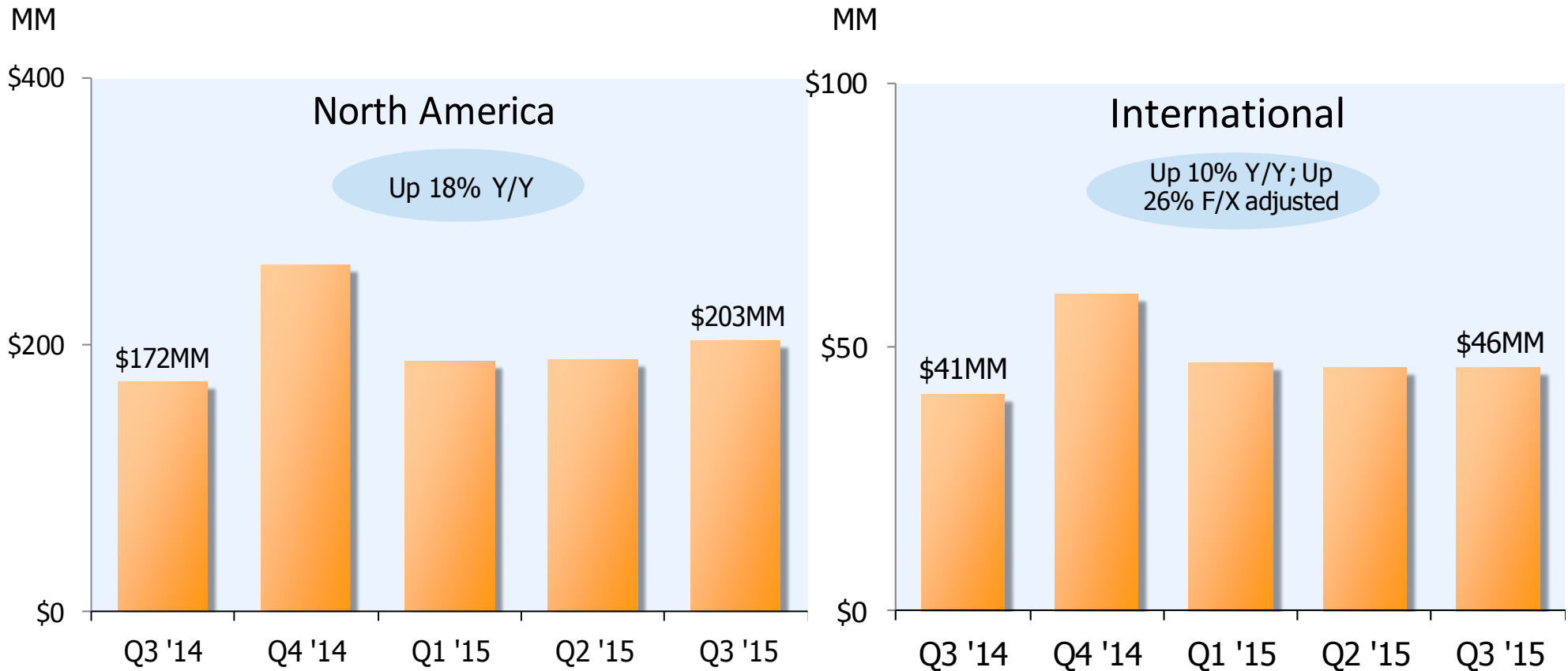
